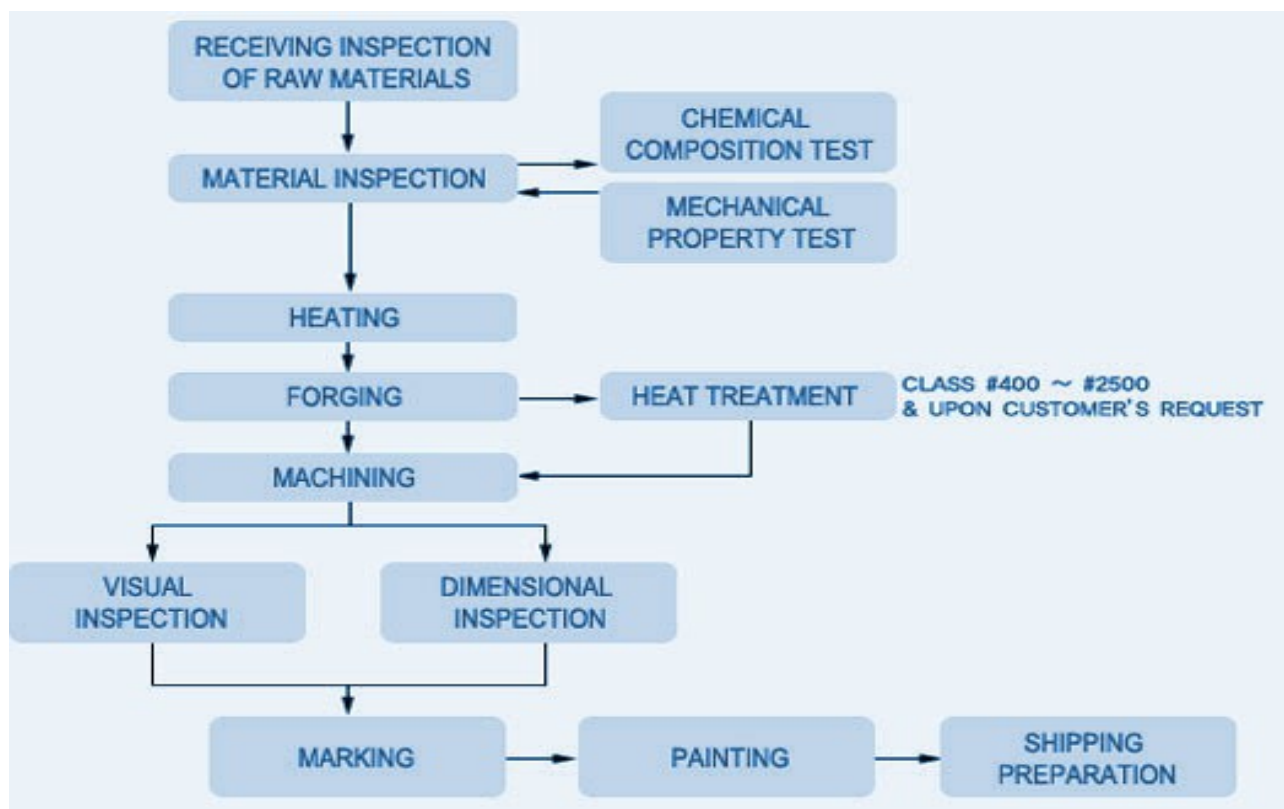

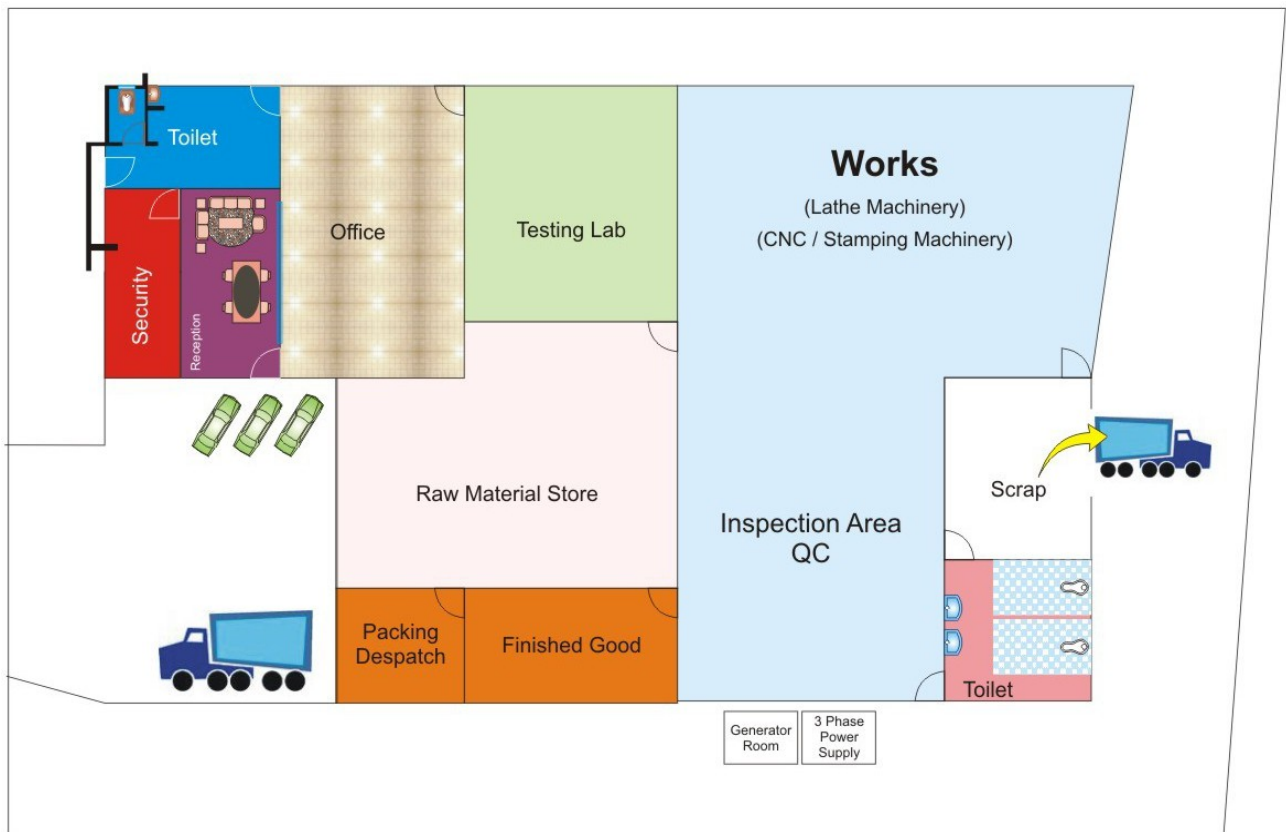


CCTV CAMERA:
